College of Humanities, Arts, and Social Sciences


Psychology

Tell us about yourself:



Tell us about yourself:

I am a 3rd year Ph.D. student in the Psychology program, specializing in Developmental Psychology. I graduated from the University of Wisconsin-Green Bay in 2020 with a B.S. in Psychology and a minor in Developmental Science. Before my undergraduate studies, I worked in the aerospace and defense sector as a project manager, where I developed an interest in moral, socioemotional, and cognitive development. I am a member of the Kids Interaction and Neurodevelopment (KIND) Lab, directed by Dr. Kalina J. Michalska, where we examine the brain bases that underlie the development of emotion understanding. My research incorporates neuroimaging techniques to study the role of intention and perspective-taking when evaluating and making judgments of moral blameworthiness throughout development and how blameworthiness is judged when social actors use indirect means (e.g., intermediaries) to inflict harm on others. Aside from my lab research, I have been involved in many departmental committees to improve the experience of graduate students in the psychology graduate program.

What is your platform and what are your priorities?

Early in my graduate program, I sought to improve the experience for myself and others. In doing so, I have been fortunate enough to have been involved in several departments and organizations. As a representative and president of the Department of Psychology's GSA, I got an inside look at how communication across campus organizations and departments can boost or hinder the experiences of graduate students. My position within GradSuccess and the Graduate Student Mentorship Program further advanced this insight, underscoring the importance of clear communication, transparency, and engaging and targeted outreach to the graduate student community. As the UC Advocacy Officer in the GSA, I heard more about the direct issues other graduate students go through and their own feedback on how these issues may be alleviated with better access to resources. If elected as VPIA, I hope to grow the network and engagement of oncampus resources for graduate students, growing resources and information for students and making the processes of accessing them more streamlined and transparent to all. From the position of VPIA, I will work closely with the many organizations on campus, such as the Well Health Promotion and Education (WELL) Department, Basic Needs, Campus Advocacy Resources and Education (CARE) Program, Office of Sustainability, Career Canter, GradSuccess, and the United Automobile, Aerospace, and Agricultural Implement Workers of America (UAW). Financial burdens, medical concerns, food and housing insecurity, the stresses of producing research and meeting programmatic hurdles, and future employment uncertainty, to name a few. The university has made efforts to aid graduate students with these struggles; however, many helpful resources are difficult to access due to poor communication about their existence and a lack of support or hidden policies that make using them challenging. As Vice President of Internal Affairs (VPIA), I aim to lessen this burden by pushing these programs to be the best they can be for students.




Why are you applying for this specific position?

Tell us about yourself:



Varun Narayanan


